Summary of policy (as applicable, please attach copies of relevant policy documents):	The Human Rights Commission and the First People's Congress to create a comprehensive national action plan that will provide the roadmap for Government and civil society about how to implement the United Nations Declaration on the Rights of Indigenous People into Australian law and policy making. \$15 million in grants will be provided to NGOs from July 2014 to facilitate their participation in developing the plan and to help them raise awareness about the declaration.
What is the purpose or intention of the policy?	To ensure Aboriginal and Torres Strait Islander people are able to exercise self-determination in all aspects of their lives, as part of the process of national reconciliation.
