This will • open up the Federal Parliament on a sitting day for a special youth question time with members and senators. • bring together 226 young people aged 15-21 from across the country (one for each member and senator). • link Australia's most motivated young people with real political power, by holding the youth parliament within the sitting Federal Parliament, and featuring selection of young people and mentoring by elected MPs. • engage with the wider Australian youth community through a strong focus on online community reporting and social media.
