## **Costing overview**

The proposal is expected to decrease both the underlying cash and fiscal balances by \$0.5 million over the 2013-14 Budget forward estimates period. This is entirely due to a net increase in expenses associated with establishing an independent Office of Animal Welfare.

The costing is considered to be of high reliability as the establishment costs are based on the capped amount as specified in the costing request and the operating costs of the Office of Animal Welfare would be entirely funded by the transfer of the Animal Welfare Branch's current resources.

The profile differs from the costing request to reflect establishment costs that are likely to be required in 2013-14 and 2014-15 for a 1 July 2014 effective date.
